TAKE OFF: 8:00 A.M.

CLINTON LAKE MARINA BOAT RAMP

Must be in line for WEIGH-IN at 12:00PM Sharp.

1. Participants must fish from a boat.
2. For safety reasons KDWP requires life jackets and throwing device accessible, we recommend two persons per boat. Life jackets to be worn on take off. Team consist of two people.
3. ONE participate of team must be an O.C.S.C. member.
4. Artificial Lures & Live Bait permitted.
5. If you have to leave tournament early you may give your fish to a trusted fisherman to weigh in for you.
6. **Lateness: Be on time for weigh in or risk being disqualified!**
7. 10 fish limit per team per day.
 - Lake or state rules will always override club limits or rules.
 - Crappie, White bass must be 10" in length BLACK and BROWN BASS 18"
 - WIPER 18"
 - WALLEYE 18"
 - **No culling after legal limit is reached**
8. Fish shall be measured with tail pinched & mouth closed.
- 9 **Illegal limits or lengths brought to weigh in will cause disqualification and possible fines from State Officials. Check fish carefully of identity & length. IF IN DOUBT THROW IT OUT!!!!**
- 10: Tie will be determined by flip of a coin.
- 11: Must have approval from Tourn. Director for take off at any other boat ramp due to weather conditions only.
- 12: Tourn. Director has authority to cancel tourn. Due to weather and /or change times due to light conditions or weather.
- 13: **No refunds on paid tournament entry fees, except canceled by Tourn. Director.**
